1. Health and Hygiene	 Usage of Shower Facilities is not allowed – customers to bring personal linens for personal use All utensils onboard must be disposable All boats to be fully cleansed of garbage & disinfected [including Jet Skis] after every use Life jackets to be disinfected after each use Rental equipment to be disinfected after each use Compulsory wearing of gloves & masks while using self renting equipment Compulsory wearing of masks & gloves for all visitors [including children] Mandatory temperature checks for all onsite staff and compulsory wearing of masks and gloves for all staff in facility 	CR	CR	СМ	R
2. Social Distancing	 All staff to practice social distancing guidelines across the operating facility as required by DM guidelines 2m clear distance between people and 4m clear distance between two groups of people Not more than 5 people in one group [can be family, friends or trainers etc.] 2. Jet Skis: One Person allowed only 3. Sky Dive Capacity: Reduce flight capacity to ensure social distancing (2m) All equipment to be thoroughly sterilized between uses, especially harnesses and protection gear. Customers are encouraged to use/purchase/bring their own goggles. Customers & Professional Divers to undergo temperature check and wear full gear All jumpers are required to wear a face mask to board the aircraft and wear it for the duration of the ride to altitude Jumpers are allowed to remove their masks during jumping to avoid any chance of the mask affecting their breath, shifting or obscuring their vision. Sky dive company should administer this measure by clearly instructing divers to ensure removing mask during freefall. No tandem jumps allowed at this stage 	CR	CR	СМ	R

Health and Hygiene	 Mandatory temperature checks for all onsite staff and compulsory wearing of masks and gloves for all staff in facility All staff to practice social distancing guidelines across the facility as required by DM guidelines High intensity sanitization of full common space at beaches in-line with DM Guidelines [includes toilets, shower areas, food kiosks, any other applicable areas] post operation hours Ensure cleaning all areas after each use Closure of shower areas/general toilets areas Guests to bring their own belongings (towels, linens, etc.) Ensure availability of hand sanitizer in all areas [toilets etc.] All utensils onboard must be disposable Compulsory wearing of masks for all guests [including children] Mandatory isolation zones provisioned to host suspected cases until transition to DHA for further checks (wherever applicable) Life jackets to be disinfected after each use 	CR	CR	СМ	R

Social Distancing	 2m clear distance between people and 4m clear distance between two groups of people in Beaches & for Sun-Beds [2m if same Family for Sun Beds] Not more than 10 people in one group on the beach [can be family, friends or trainers etc.] Open at lower capacity (30%) to allow for sufficient social distancing 	CR	CR	СМ	R
3. Regulation & Policies	 Access only limited to hotel guests, whereas selling beach access tickets to non-hotel guests is not allowed F&B is allowed. Restaurants, cafes and food stands to follow necessary guidelines for the sector Water Sports Activities to follow previously announced guidelines Contactless payments to be encouraged, yet cash payments are allowed Public Announcements and placement of rules in highly visible areas including entrances and other public areas 	CR	CR	СМ	R
